### **New Business:**

### **Quorum Number:**

1. Constitutional amendment changes: Members participated in a long discussion on the pro's and con's of reducing the quorum number from 20% to 10% in order to conduct club business at the General Meetings. Members decided to present the reduction of the quorum number to 10% to the membership for a vote at the March meeting.
